

## Multnomah County Sheriff's Office Early Release Report for April 2005

For the month of April, 612 releases occurred. This is the highest number of releases in over eight years, and is second only to the 677 released in January of 1997. Out of the 30 days in April, there were only 6 days when releases did not occur. Of those released, 491 were unsentenced while 121 were sentenced. For this calendar year, total releases equal 1667 with the fiscal year releases now equaling 3613.

Listed below are the crime descriptions of those released in April and the number of occurrences for each. Please note that charges are separated by Sentenced and Unsented Releases.

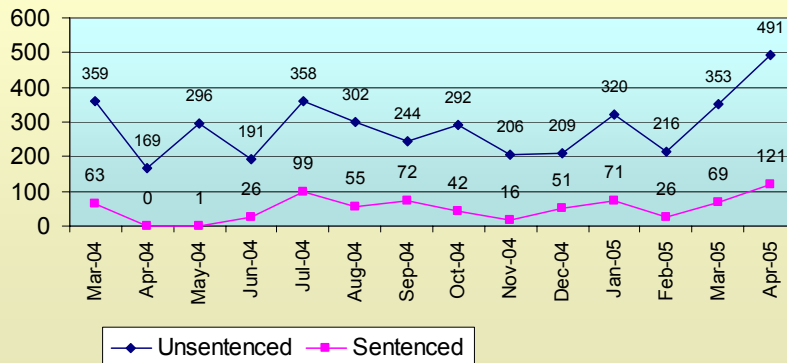

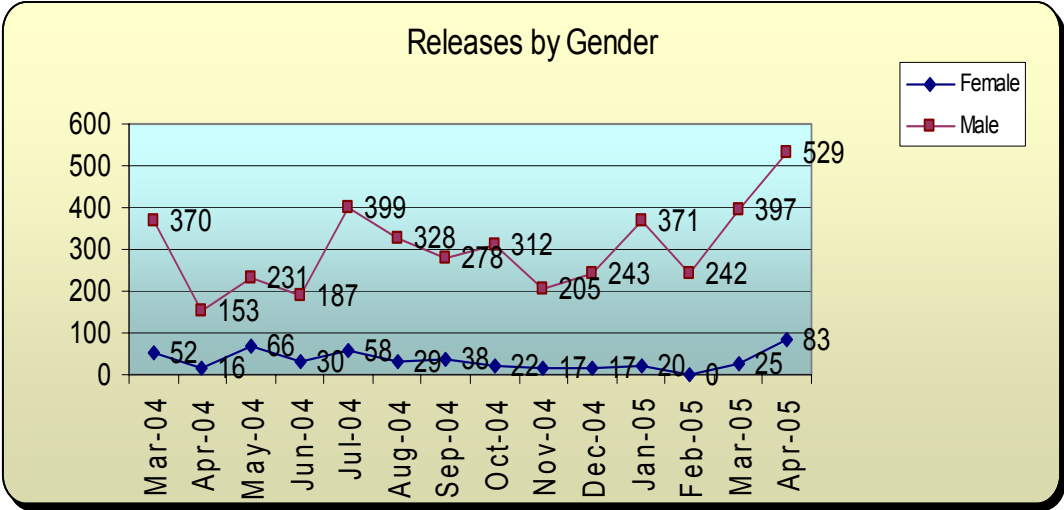
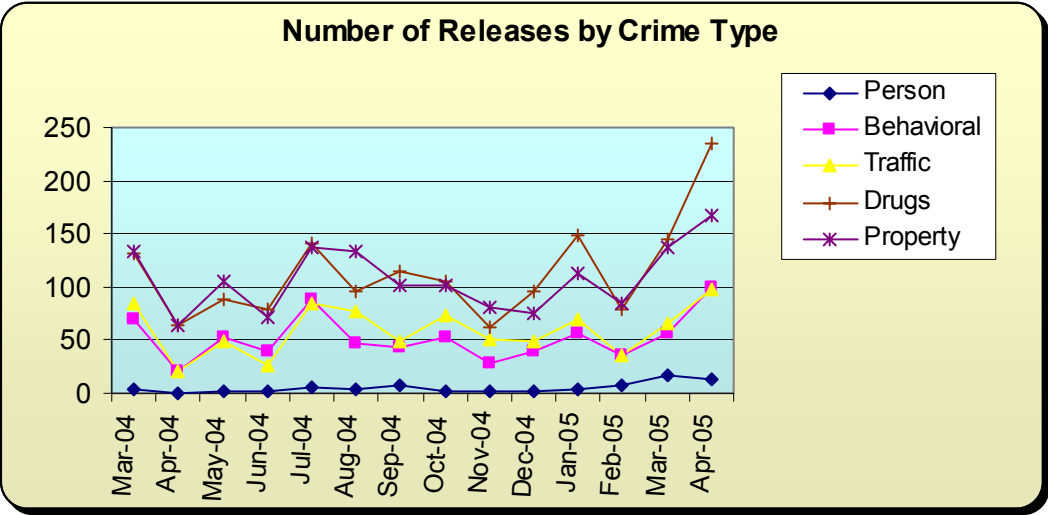
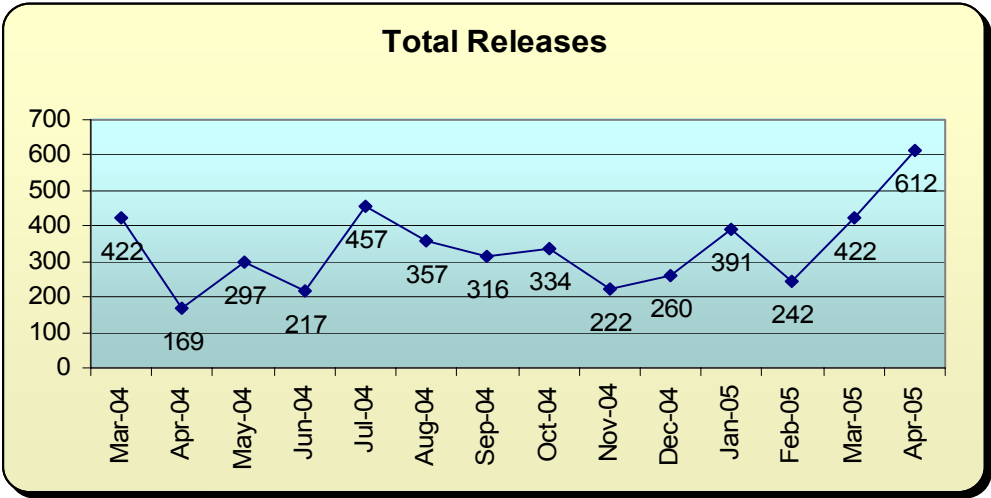

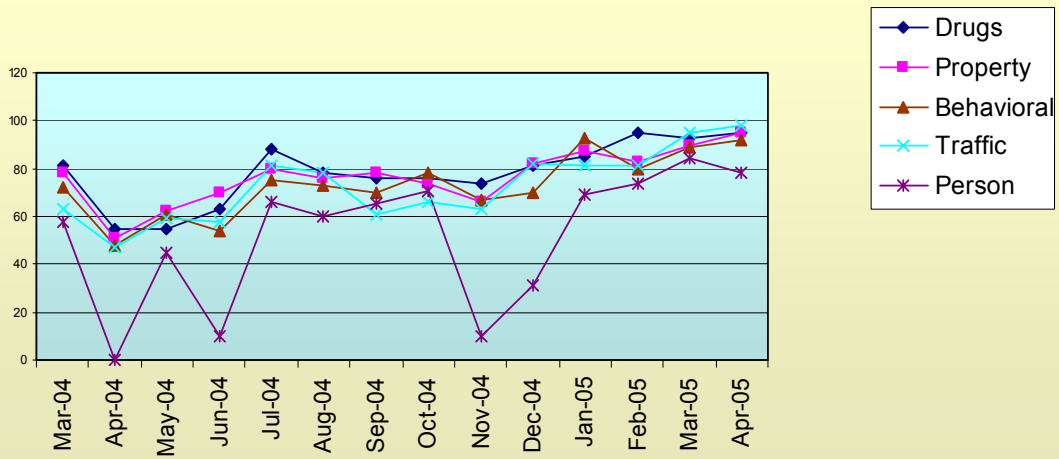
