Monthly Emergency Population Release Report - August 2005

August ended with a total of 541 emergency population releases; second highest month of releases in two years. Early releases occurred on 18 of August's 31 days. Of those released early, 489 were unsentenced and 52 were sentenced while 491 were males and 50 were females. Total releases for this calendar year have reached 3,298; of those 1,217 releases occurred during the summer months of June, July and August this year; a 17% increase from last summer. Listed below are the crime descriptions of those released in August, and the number of occurrences for each.

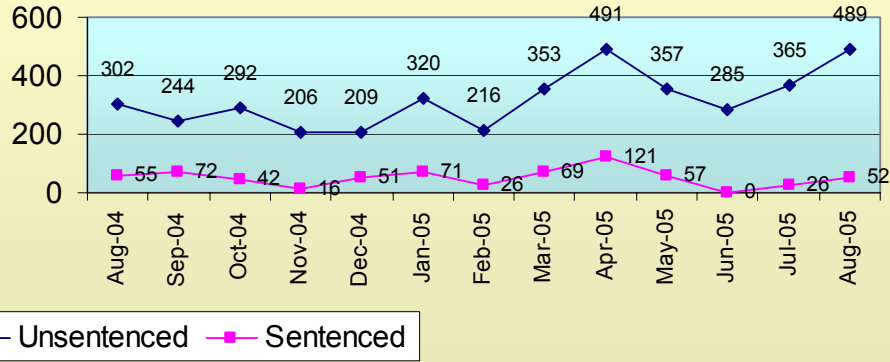

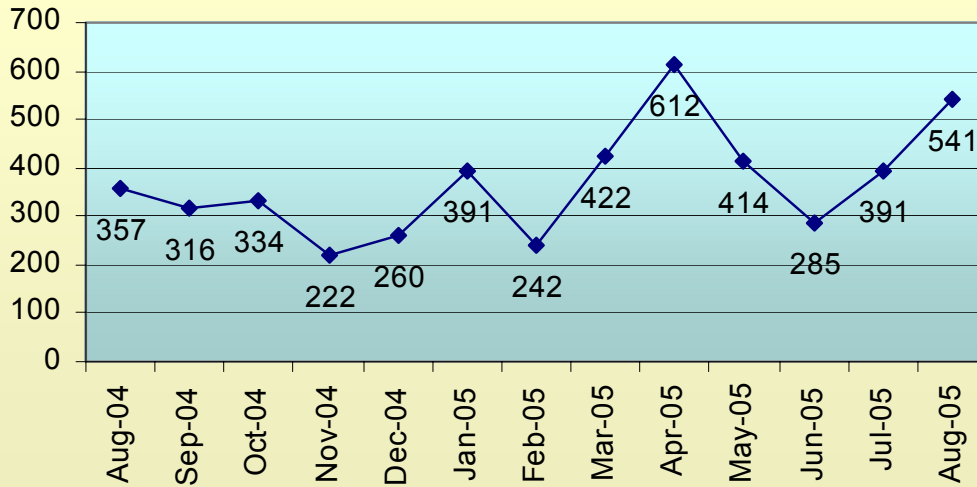

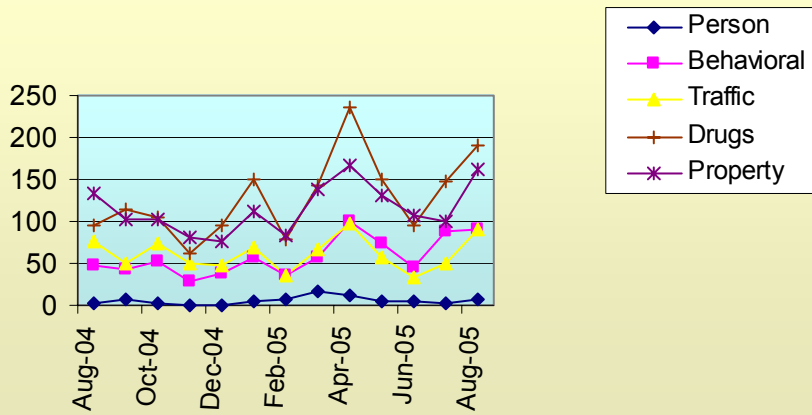
Unsentenced vs. Sentenced Releases



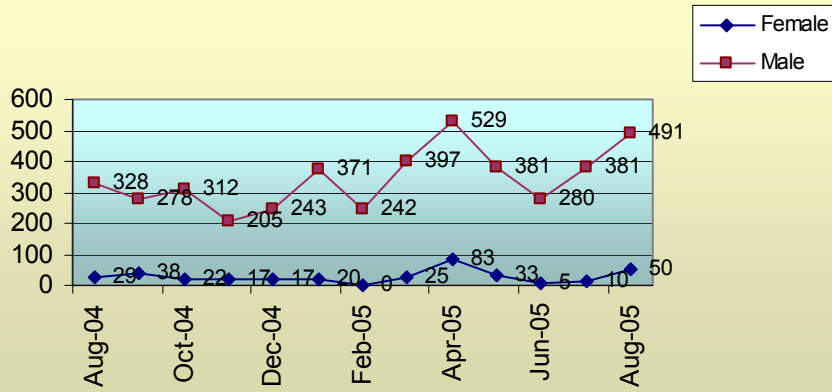
Total Releases



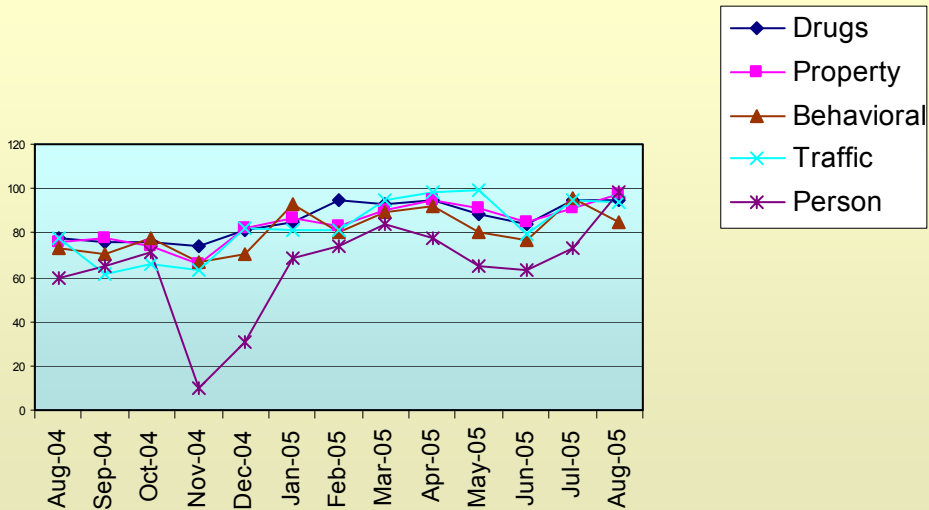
Number of Releases by Crime Type
