

Matrixing Report for January 2005

For the month of January, 391 releases occurred. This is slightly more than a 50% increase from December 2004 s total releases of 260. There were 320 unsentenced and 71 sentenced releases. The total number of releases since the beginning of the fiscal year (07/01/04) is now 2337. Listed below are the charges of those released in January and the number of occurrences for each.
