

Multnomah County Sheriff's Office  
**Early Release Report for March 2005**

For the month of March, 422 releases occurred. This is the second highest number of releases in one month within the last year, exceeded only by the 457 released in July, 2004. This month's total is a 74% increase over the previous month's total of 242. Of those released in March, 353 were unsentenced while 69 were sentenced. For this calendar year, total releases equal 1055 with the fiscal year releases now equaling 3001.

Listed below are the crime descriptions of those released in March and the number of occurrences for each. Please note that charges are separated by Sentenced and Unsented Releases.

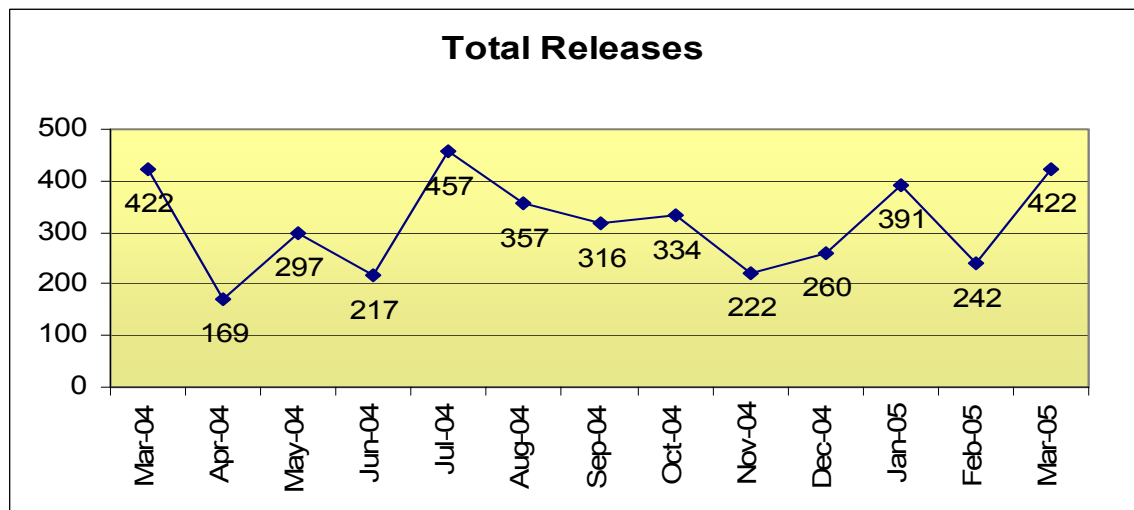
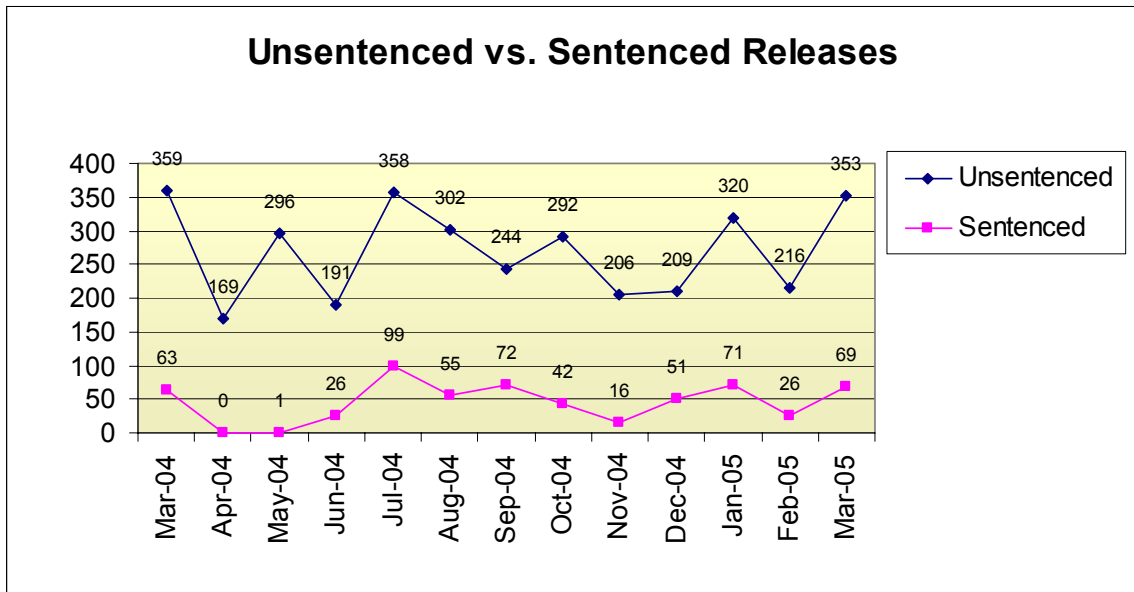
