

Multnomah County Sheriff's Office Early Release Report for May 2005

For the month of May, 414 releases occurred. Although the total number of releases for May is less than the previous month's total of 612, it is still above the twelve month average of 348. Releases occurred on 19 of May's 31 days. Of those released, 357 were unsentenced while 57 were sentenced. For this calendar year, total releases equal 2081 with the fiscal year releases now equaling 4027.

Listed below are the crime descriptions of those released in May and the number of occurrences for each. Please note that charges are separated by Sentenced and Unsented Releases.

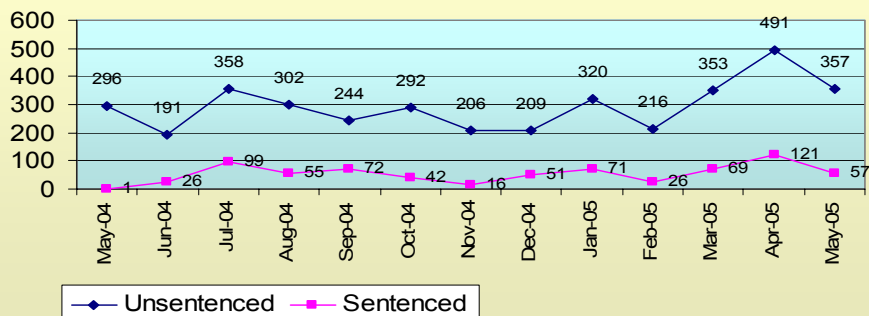

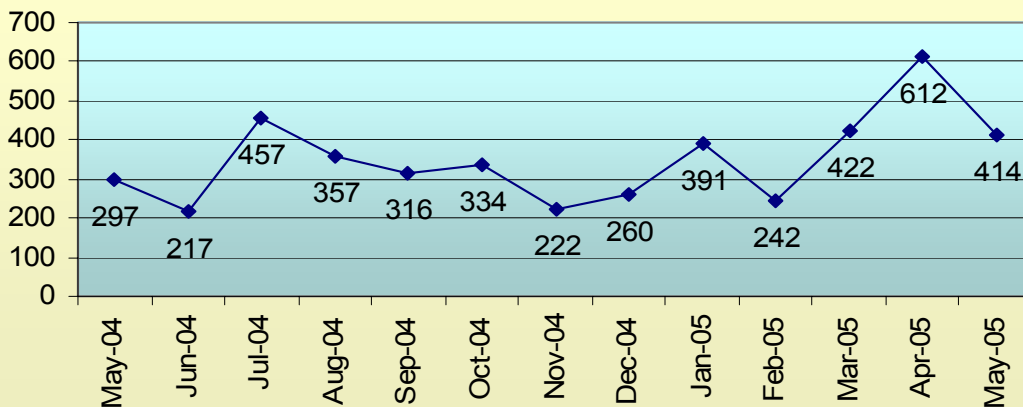

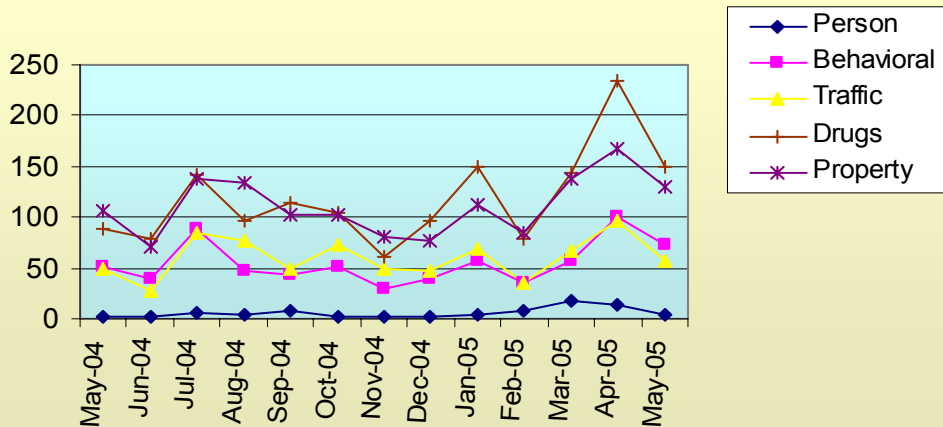
Unsentenced vs. Sentenced Releases



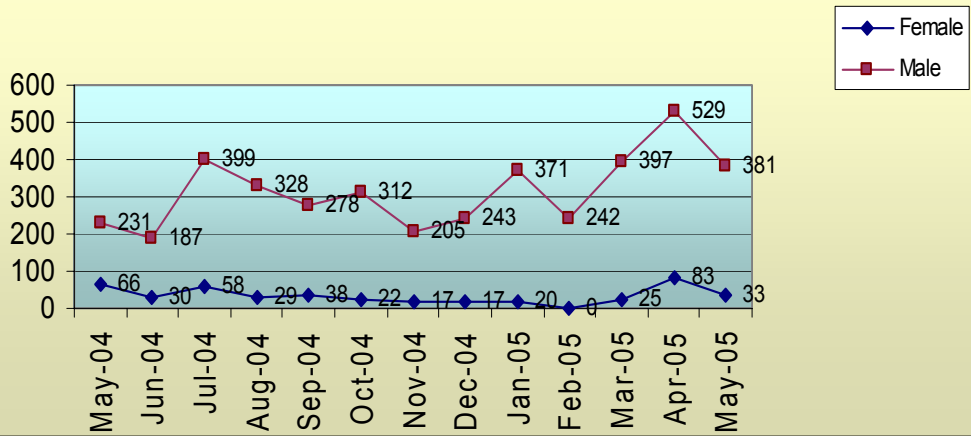
Total Releases



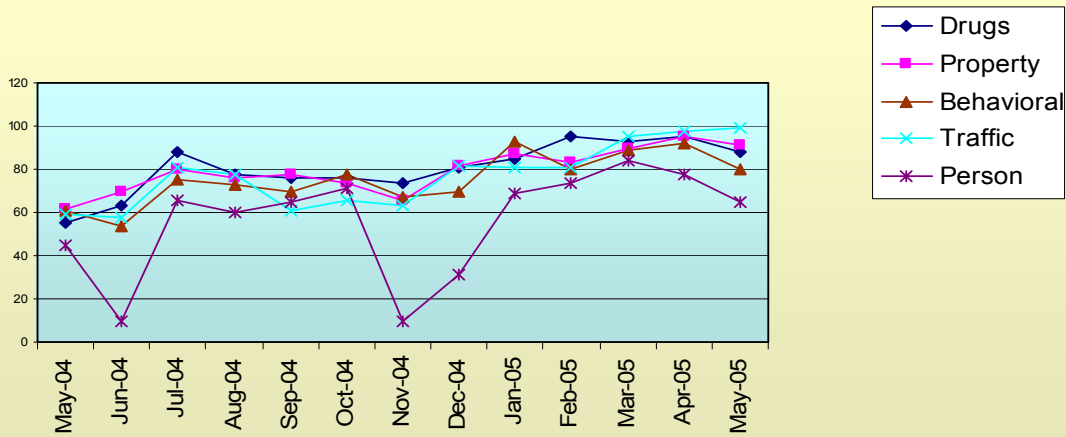
Number of Releases by Crime Type
