

## Multnomah County Sheriff's Office Monthly Emergency Population Release Report - October 2005

October ended with 447 emergency population releases occurring on 21 days during the month; a 4.5% decrease from September. Of those releases, 373 were unsentenced and 74 were sentenced while 437 were males and 10 were females. Total releases for the first ten months of this calendar year have reached 4,212; a 24% increase over 2004's yearly total of 3,395 releases. Listed below are the crime descriptions of those released in October, and the number of occurrences for each.
