Monthly Emergency Population Release Report - April 2006

April ended with 309 Emergency Population Releases occurring on 18 days during the month; an 85% increase from March, however still 98% below the April 2005 total of 612 Emergency Population Releases. All 309 releases were unsentenced; 241 were males and 68 were females. April's highest release score was 66; a 16 point rise from March's highest score of 50. In April of 2005 the highest release score was 98; 32 points higher than this April. Average score for April releases was 34 while in April 2005 the average score was 42. Jail capacity stayed the same at 1690 beds during April. Listed below are the crime descriptions of those released in April, and the number of occurrences for each.
