Monthly Emergency Population Release Report June 2006

June 2006 ended with 246 Emergency Population Releases occurring on 13 days during the month. This is nearly equal to May's total of 247 releases and 16% lower than June of 2005's total of 285 releases. All of June's 246 releases were unsentenced; 220 males and 26 females. During June, early releases of Drug, Person and Traffic crimes remained virtually the same as May; while releases of Behavioral crimes decreased by 68% and releases of Property crimes increased by 49%. June's highest score released was 69 and average release score was 36; both totals are a 1 point increase over May 2006. June saw a high score released of 69; a 23% decrease from June of 2005 when the high score released was 85. Jail Capacity remained at 1,690 beds during June; 114 beds more than June of 2005 (1,576 beds). Listed below are the crime descriptions of those released in June, and the number of occurrences for each.
