Monthly Emergency Population Release Report July 2006

July 2006 ended with 197 Emergency Population Releases occurring on 11 days during the month. This is 49 early releases less than June, totaling a 25% decrease for the month. This July's total is 50.4% less than July 2005's total of 391 early releases. Of July's 197 early releases 185 were unsentenced, 12 were sentenced; including 178 males and 19 females. During July, total early releases of Drug and Behavioral crimes remained close to June, however early releases of Person, Property and Traffic crimes dropped by 75% to 100% over June. July's highest score released was 87; average release score was 41; as decrease from July 2005's highest score released of 96 and the average score of 42. Jail Capacity remained at 1,690 beds during July, compared to 1,576 beds in July 2005. Listed below are the crime descriptions of those released in July, and the number of occurrences for each.
