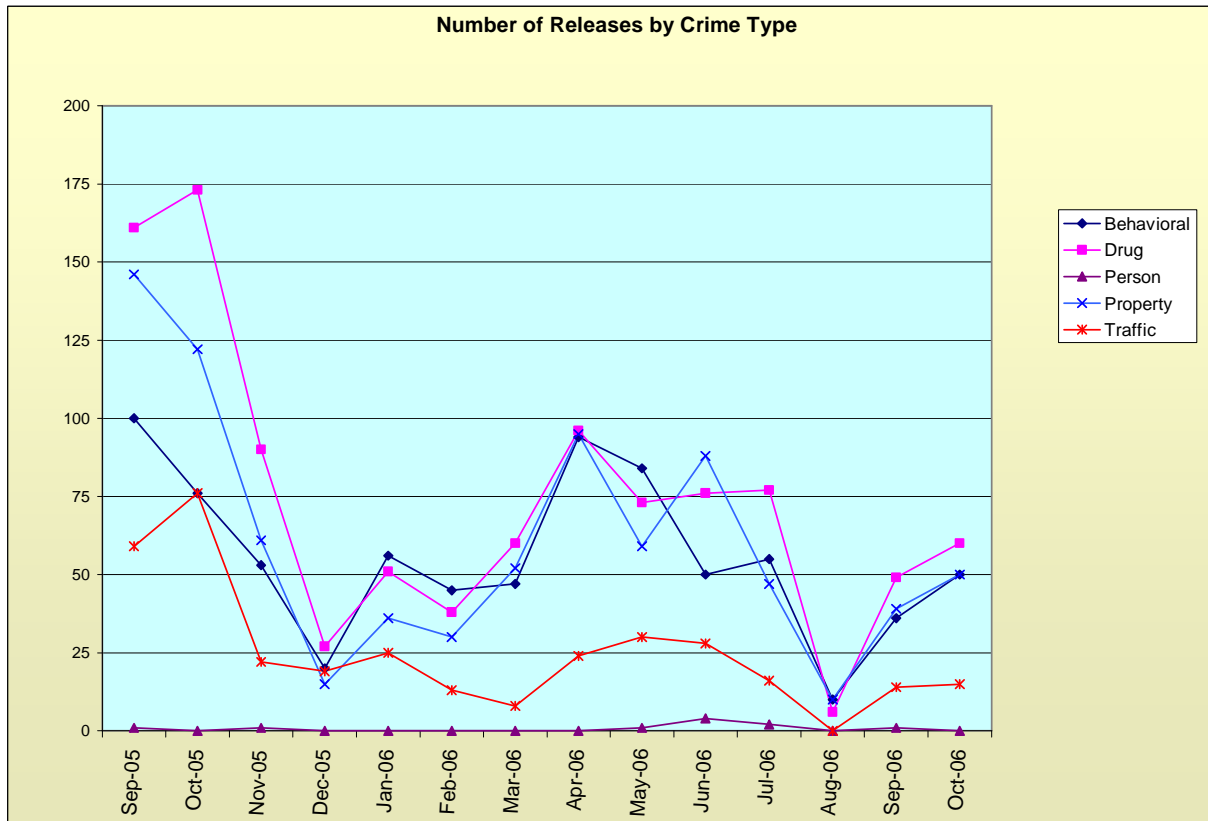
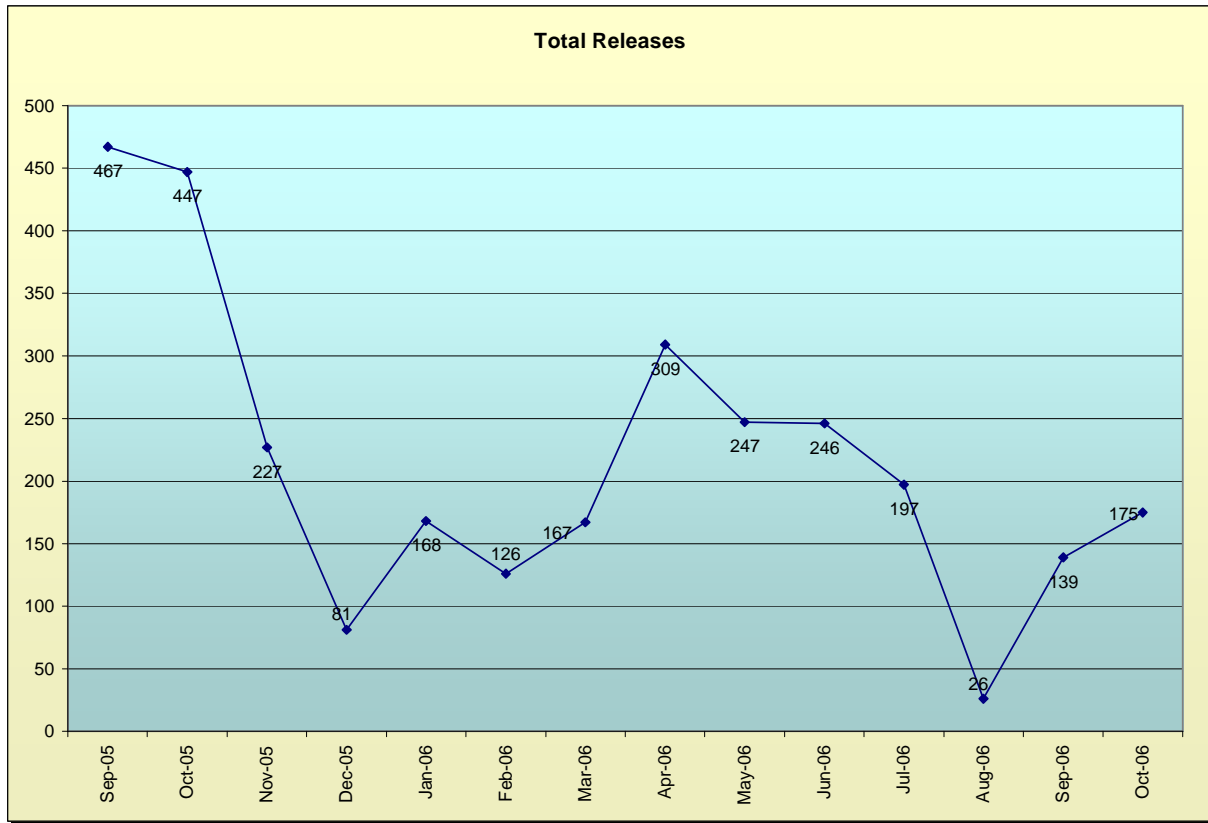
**Monthly Emergency Population Release Report
October 2006**

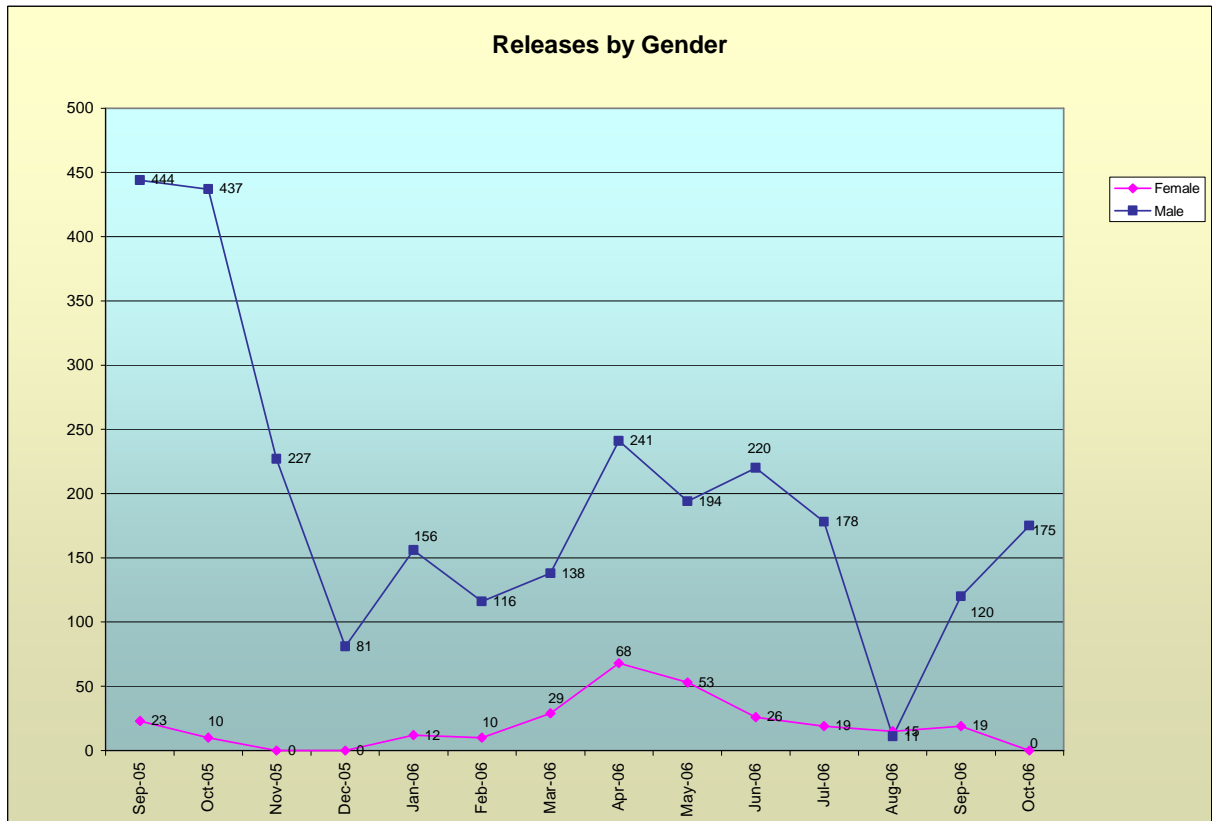
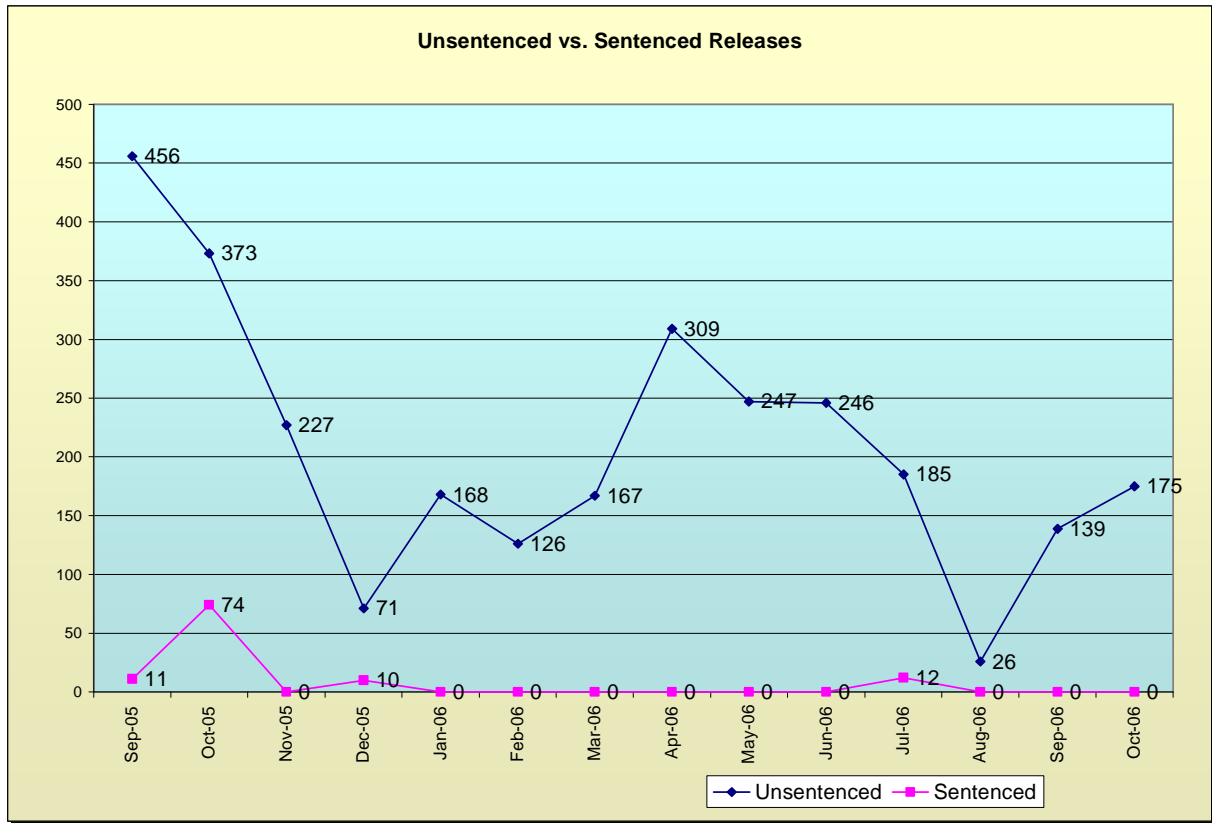
Emergency Population Releases totaled 175 for October, occurring on 10 days during the month. This is an increase of 26% from the September total of 139 releases and a 61% decrease from last year's October total of 447 releases. All of October's 175 early releases were males. High score for early releases during October reached 147; about the same as September's highest release score of 149, and 41% higher than October of 2005 when the high release score was 87. In October of 2005, the County was still releasing sentenced persons. With the change in policy, the County is no longer releasing sentenced persons which are causing the overall score to increase. The average early release score for October was 51; 10 points lower than September's average score of 61 and 10 points higher than October of 2005 when the average score was 41. Jail capacity remained at 1,690 beds during October. Listed below are the crime descriptions of those released in October, and the number of occurrences for each.

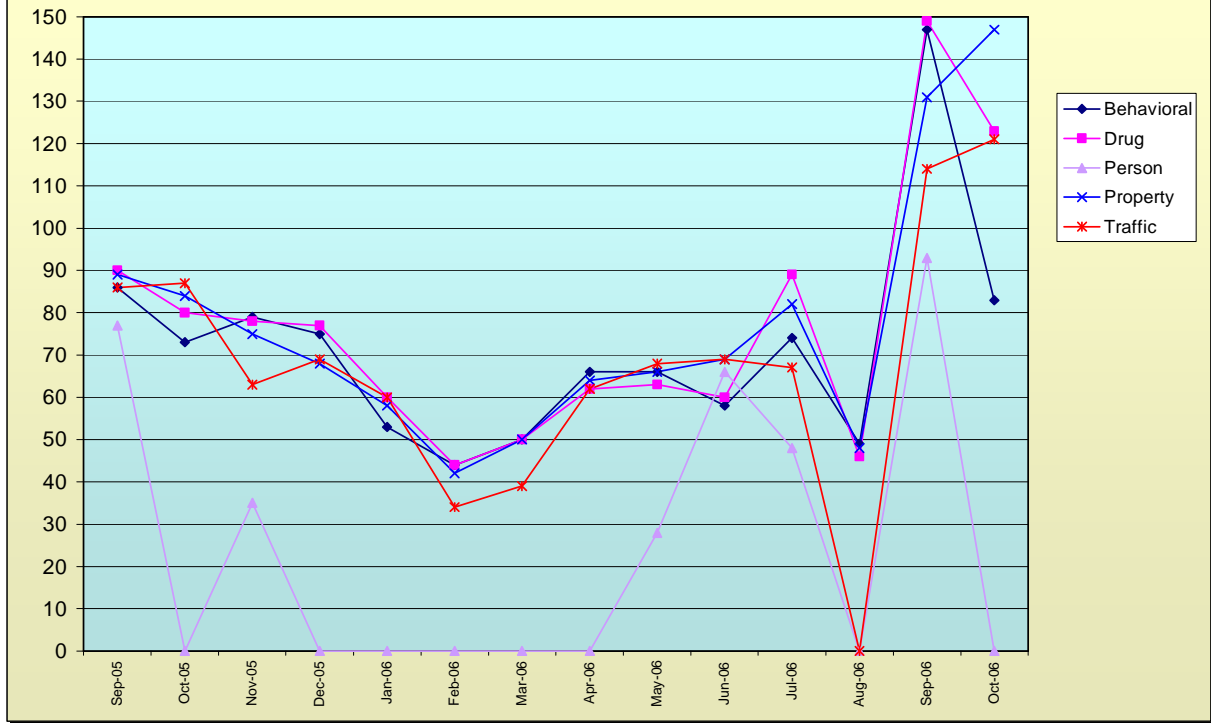
