## Introduction

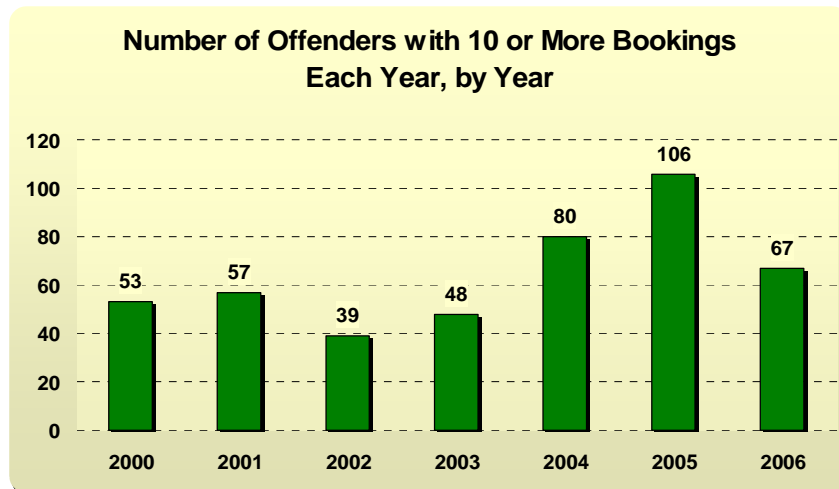
The *Frequently Booked Report for Calendar Year 2006* identifies who has been frequently booked into the Multnomah County Jails within the last year. It also provides comparisons to 2005 offenders who meet the same criteria for the category. Frequently booked data will be released semi-annually, at the end of both fiscal and calendar years.

This report was created from booking, housing, crime type and demographic data going back to January 1, 2000. The numbers include not only those who were processed through booking and lodged, but also those instances when a person was arrested and brought into the booking facility to be given a citation, identified, checked for warrants and then released (Cite & ID). Cite & ID bookings were included as they also contribute to arresting agency and corrections booking staff workload. Unless otherwise specified within this document, Cite & ID bookings are incorporated into the analysis.

To be identified as frequently booked for this study, an offender would have to have been booked *at least ten times* during the last calendar year. Their name, SWIS ID, primary charge, arresting agency and length of stay for each instance were taken from DSS-J via Cognos query. Based on query composition, it is unknown whether the booking was the result of a warrant. Offenders were queried back to January of 2000 in an effort to determine any chronic activity. This data was then brought into Microsoft Access and subsequently into Excel for analysis. All information contained within this document is public record. All charts within the body of this report are replicated in larger scale at the end of the document to allow for greater scrutiny. Names and charges of persons included in the aggregate data can also be found following this narrative.

## Overview: 2005 – 2006 Comparison

The number of persons with ten or more bookings in a given year always shows some fluctuation, with the number increasing every year from 2002 through 2005. However 2006 saw a 37% decrease in persons with 10 or more bookings, the first downturn in five years.



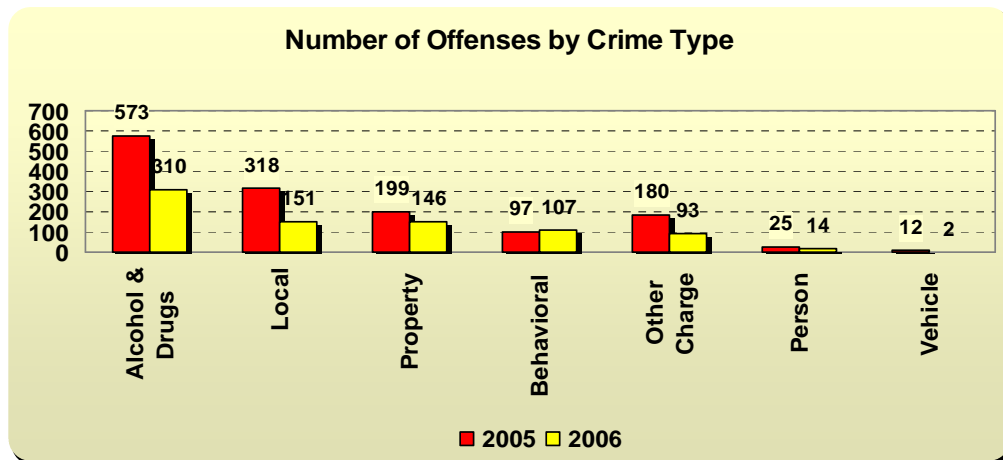
## Chronic Offender Activity over Time

17 offenders that had at least ten bookings in 2006 have had some activity each year going back as far as the five previous years. The on the following page compares the six consecutive year's activity (report year plus five years prior) from the 2005 frequently booked to 2006. Each subsequent year after 2000, the number of frequently booked with previous criminal activity increases.

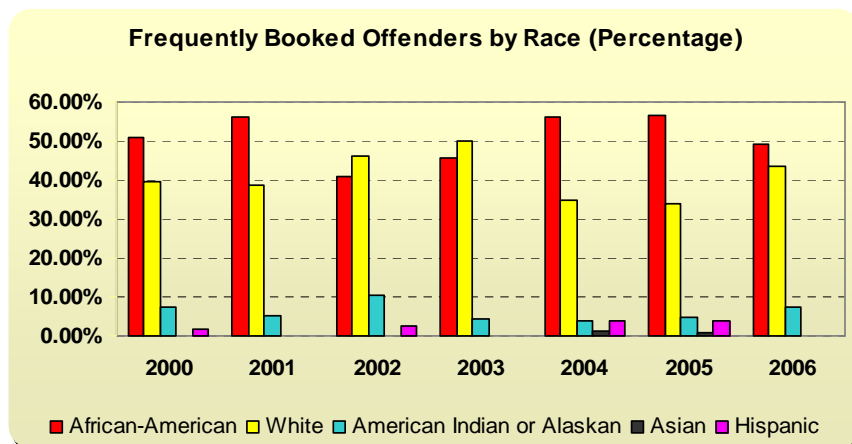
### Comparisons by Crime Type

There was a significant drop in alcohol and drug related bookings in 2006. This was principally due to the reduction in the number of Possession of a Controlled Substance (PCS) arrests. (527 in 2005, 220 in 2006). The increase of behavioral crimes in 2006 was due to a significant increase in arrests for interfering with Public Transportation. These arrests were up from 13 in 2005 to 50 in 2006. A complete breakdown of 2006 Primary Charges is provided as appendix 1.

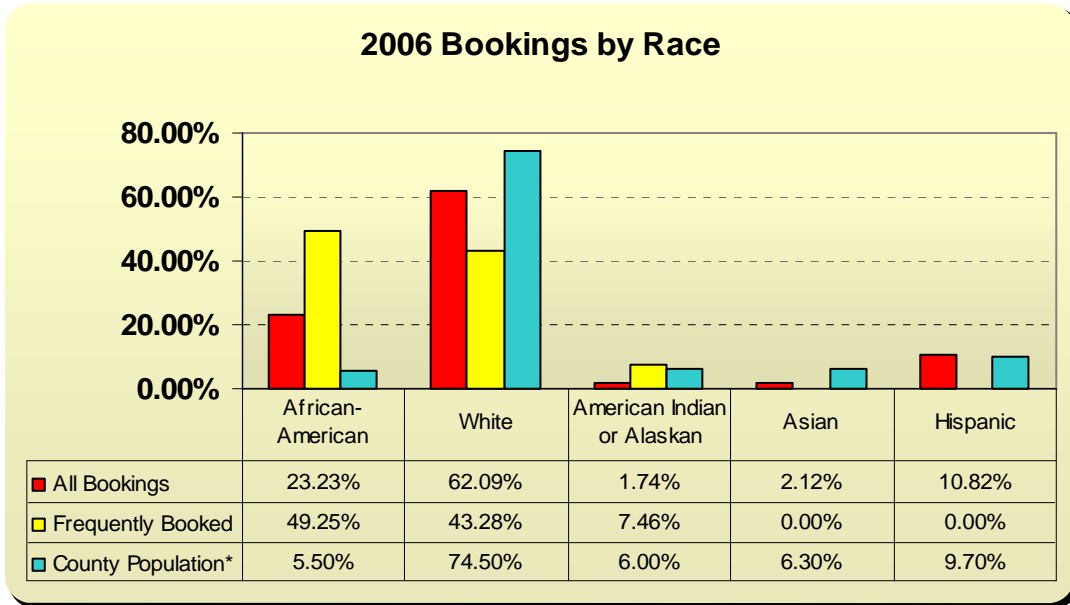


### Bookings by Race

In 2006, there was a 40% decrease of African-Americans in the frequently booked category (from 60 in 2005 to 36 in 2006). At the same time, there was only a 12.1% reduction in Whites (from 33 to 29). As seen on the following chart, this caused the disparity between these two races to decrease by 17%. The American Indian or Alaskan percentage moved from 5 to 7% over the year, while there were no frequently booked in 2006 in the categories of Asian and Hispanic.



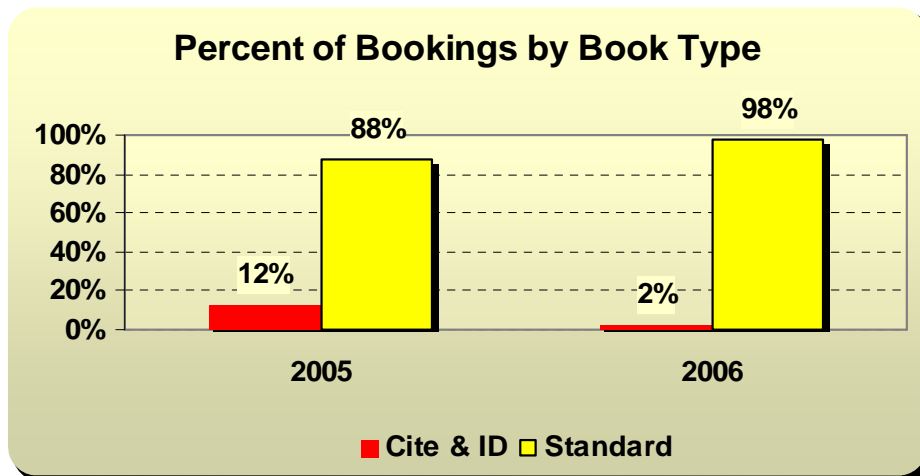
The African American population of the county is 5.5%. Bookings for this group overall is 23.2%. However, they are over 49% of the frequently booked population.

### Booking Types and Arresting Agencies

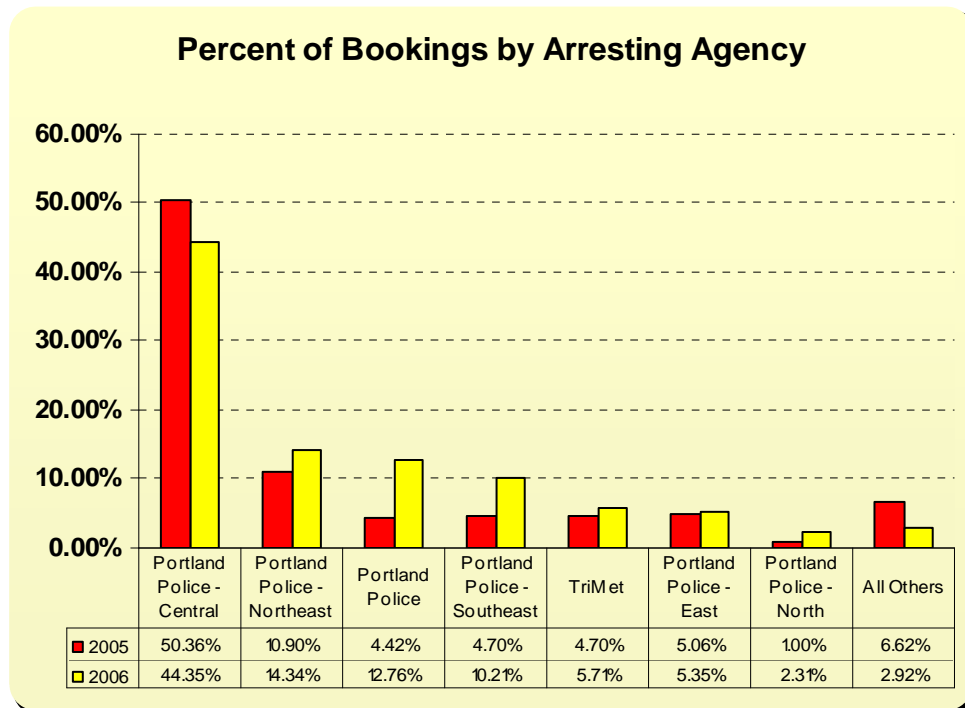
There were a total of 823 bookings in 2006, down from 1404 in 2005. In 2005, 12% of all bookings for the group were Cite and ID. The remaining 88% were Standard bookings. In 2006, only 2% of all bookings were Cite and ID with 98% being Standard.



Listed below are the bookings by arresting agencies for 2005 and 2006. Note that with Cite & ID bookings, no arresting agency name is given, thus they are listed as “Not Entered”.

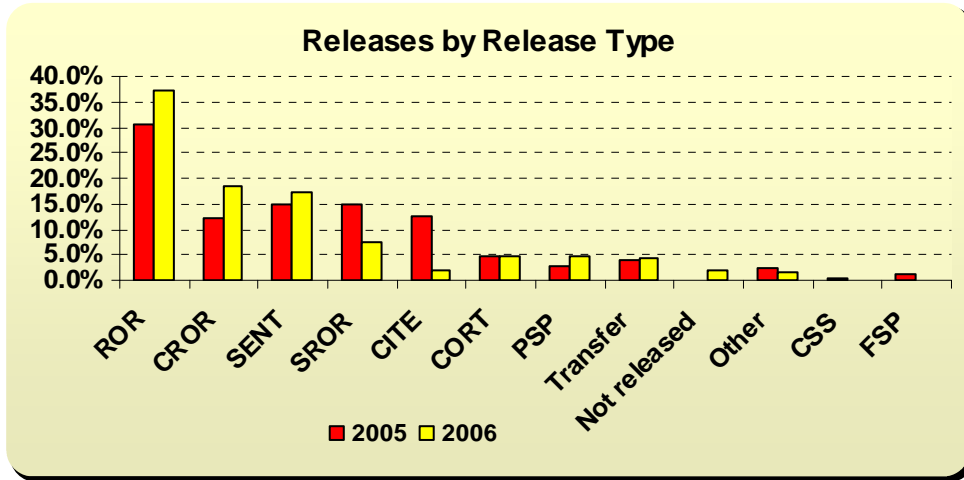

As in 2005, Portland Police was responsible for the majority of the arrests (76% in 2005, 89% in 2006). Percentages are detailed further to include precinct in the next graph.

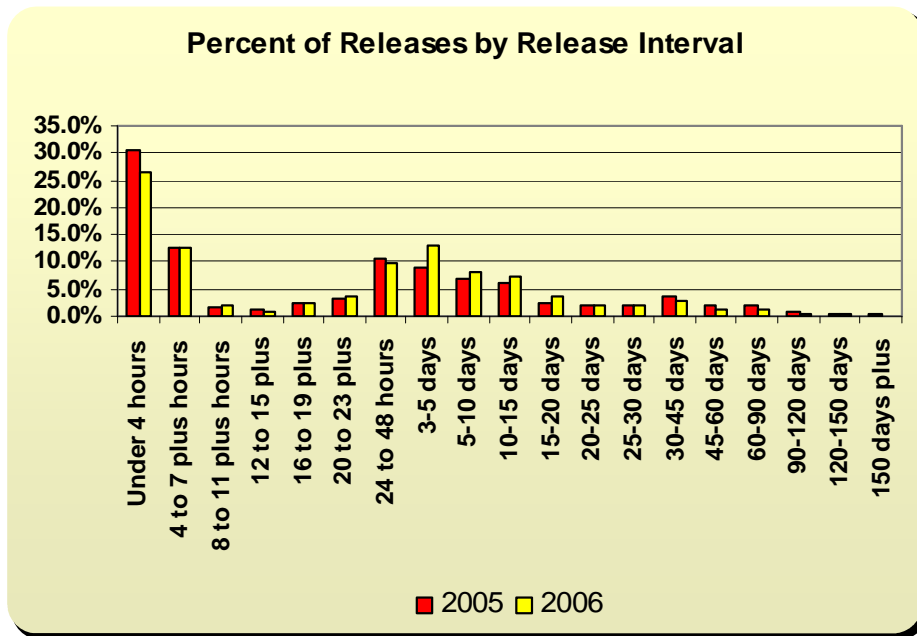


**Release by Release Type & Release Time**

In both years, 2005 and 2006, the release type most employed was Release on Own Recognizance (ROR), a function performed by the Department of Community Justice for the courts during the booking process. A far lesser percentage of the frequently booked were released during Emergency Population Release events (shown as SROR below) during 2006. As seen on the next graph, because of this, higher percentages of offenders were released at completion of sentence (SENT) or through Court Ordered Release on Own Recognizance (CROR).

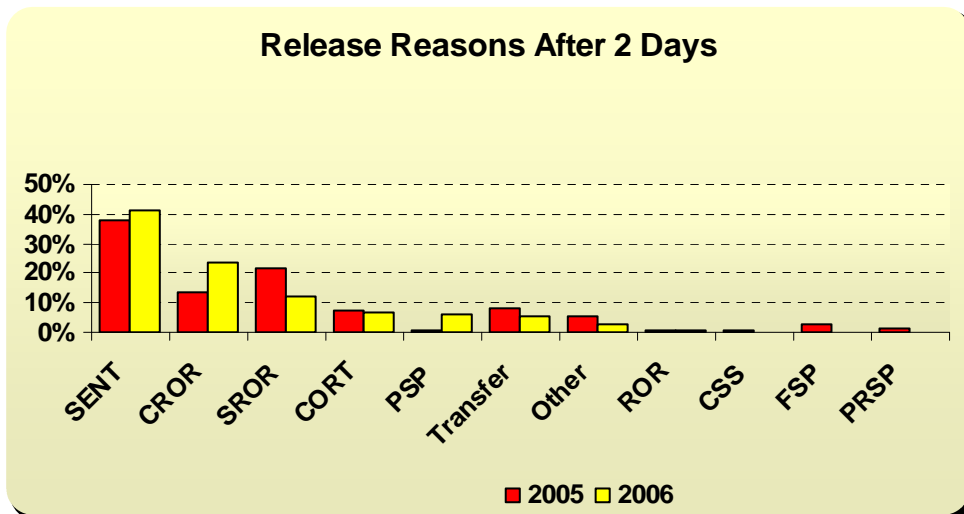
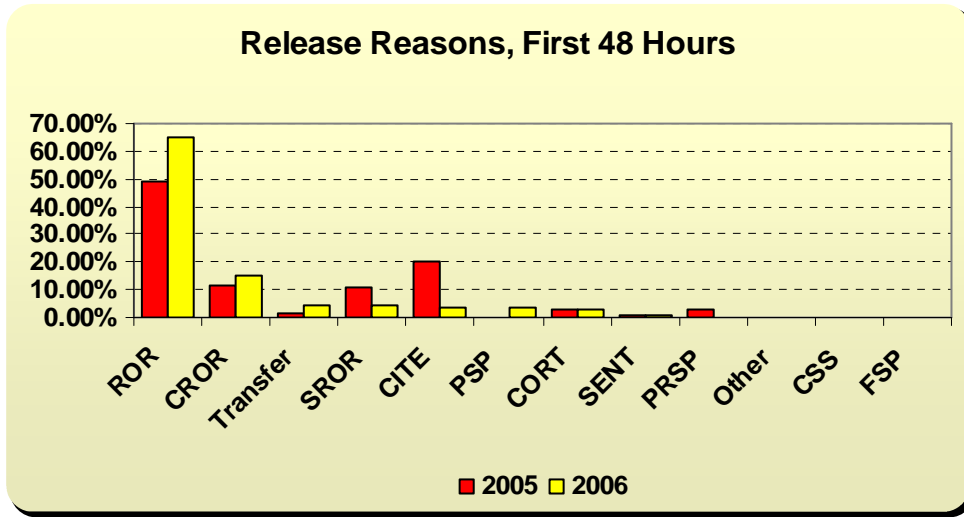


The chart below shows a span of time from under 4 hours to over 150 days and the percentage of releases within each interval. It illustrates that the majority of releases occur within the first 48 hours. In 2006 more inmates were held longer in the ranges between 3 days and 25 days than in 2005. In 2006, fewer persons were released within the first 4 hours than in the previous year.



The next two charts shows how release reasons change between the first 48 hours and releases after 48 hours. Within the first 48 hours the most common release method used was ROR.

Understandably, all releases for Cite & ID occur during this time frame as well. The increase in ROR and CROR releases seen in both charts in 2006 may be attributed to the fewer SROR releases.

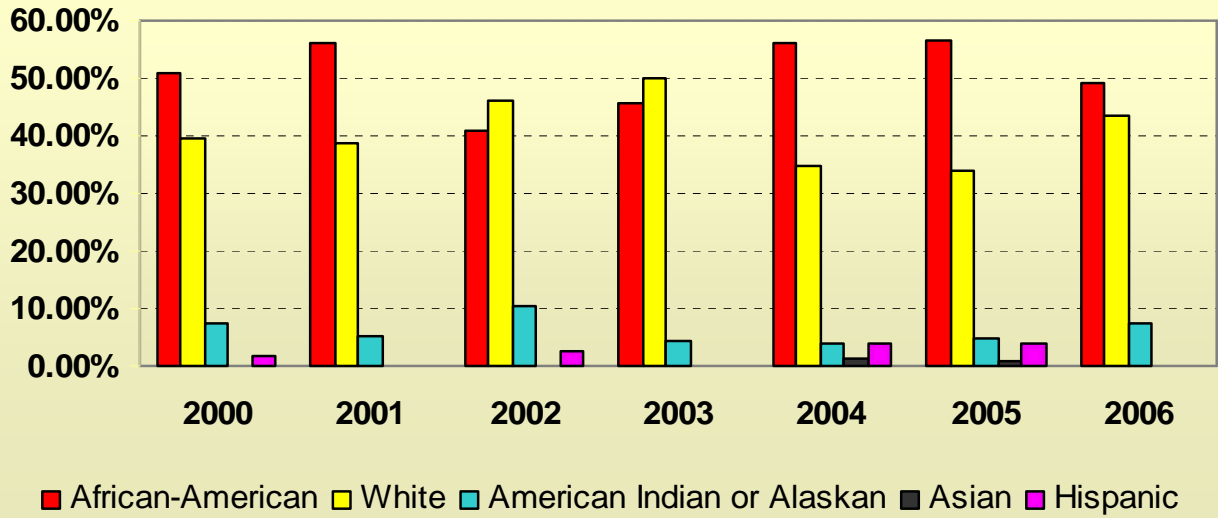

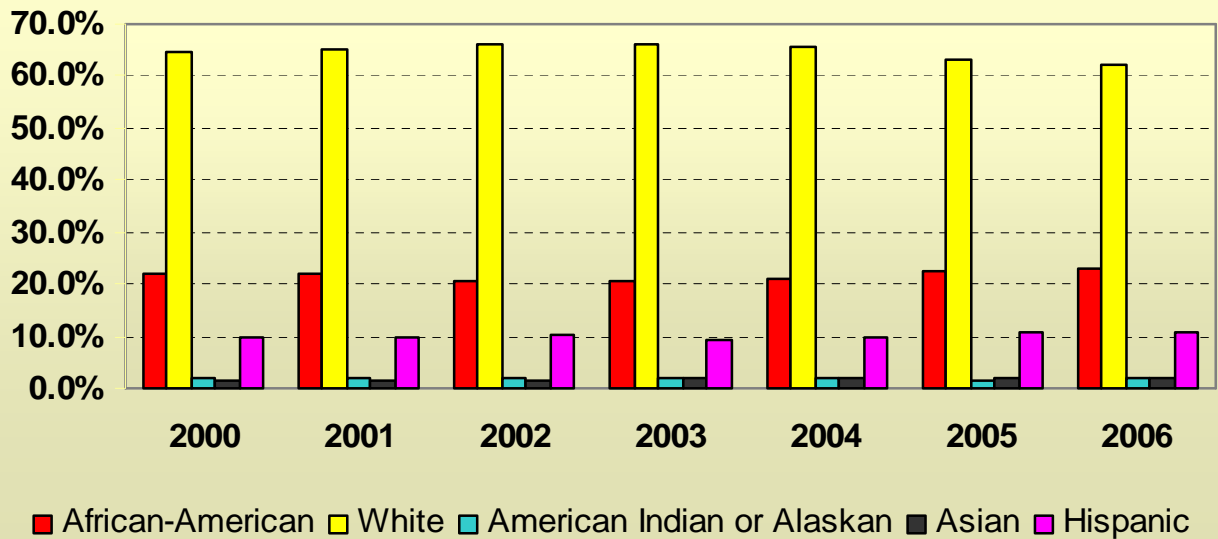
## Percent of Bookings by Book Type



### Frequently Booked Offenders by Race (Percentage)

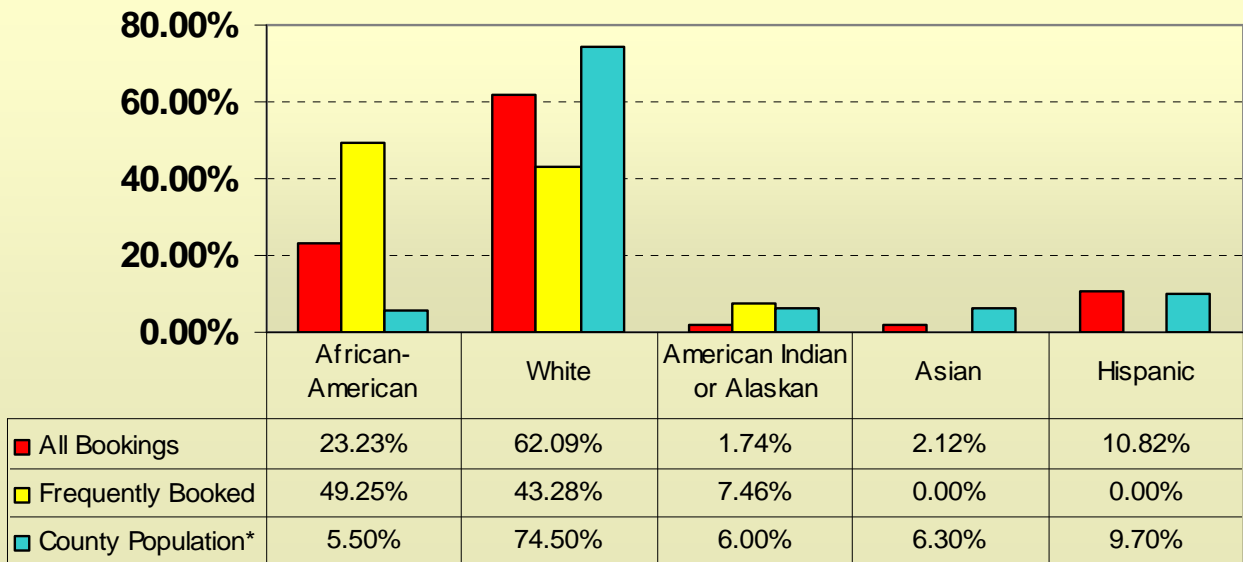


### All Booked Offenders by Race (Percentage)

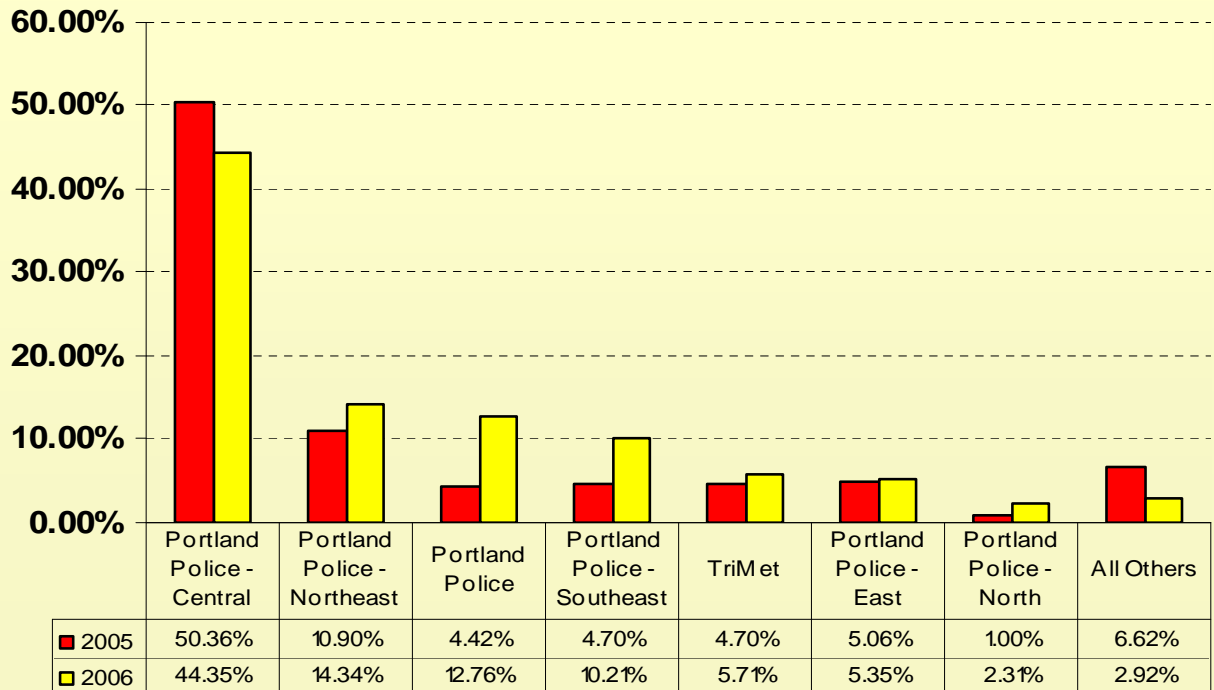

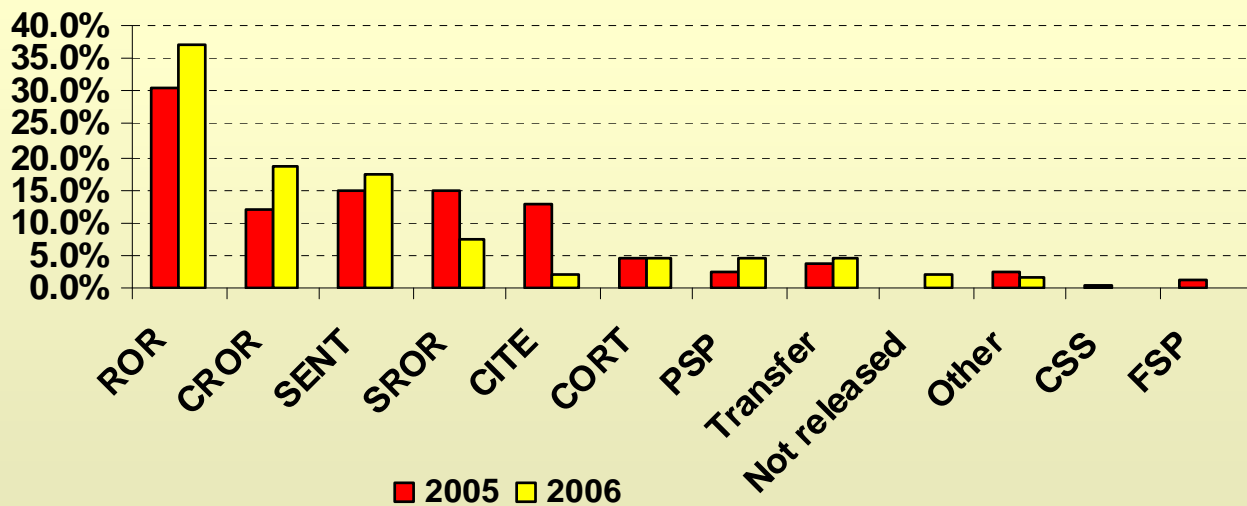
### 2006 Bookings by Race



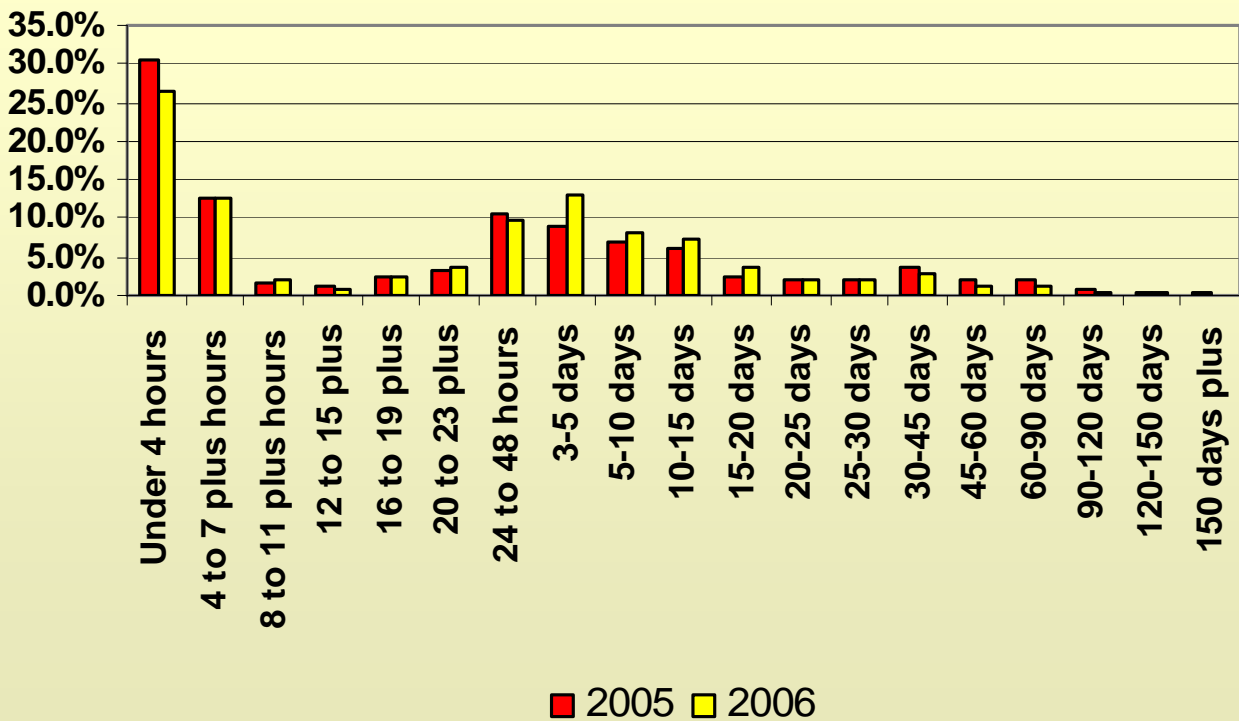
### Percent of Bookings by Arresting Agency



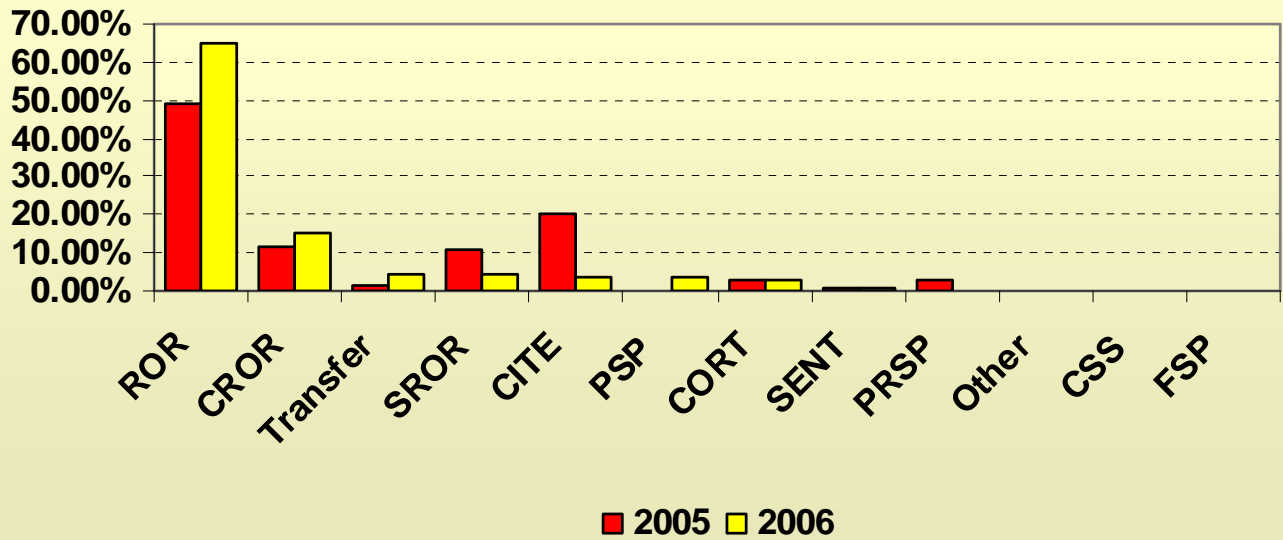
### Releases by Release Type
